

For offences under the Protection from Harassment Act, the following questions must be answered by the complainant:

Offence of causing harassment, alarm or distress under section 3 or section 4 of the Act:

1. What exactly is the behaviour or communication that you are complaining about?

(i) Harassment of my person at my place of residence by an individual alleging to work for Nanyang Technological University; (ii) Extortion in the termination letter attempting to silence me and remove me from Singapore; and (iii) Rupshi Mitra bullied me over a long period of time.

2. How is it threatening, abusive or insulting?

(i) I do not wish to find people knocking on my door after a food delivery person wrongly rings my door apparently by accident, and then standing in the hallway of my residence as they make loud phone calls; (ii) the language used in the termination letter is extortionist; (iii) Rupshi Mitra's communications are unprofessional and very abusive and insulting because she is incompetent to fulfill scientific obligations but abuses her power to speak down to me.

3. How did it make you feel? Did you feel harassed, alarmed or distressed?

(i) I felt harassed, alarmed, distressed, and unsafe that Nanyang Technological University might have sent someone to harass me at my place of residence; (ii) I felt deeply shaken by the termination letter and the threats should I not be silent; and (iii) Rupshi Mitra's bullying was humiliating, demeaning, and very distressing.
