Without prejudice

Hello

I have been reaching out to the OHCHR for help, please see my message below and three (3) files attached. If I should contact another UN office for dire problems I am facing in what appears to be organized crime in Singapore, please let me know.

Briefly, I was ordered to engage in illegal activity while employed at Nanyang Technological University Singapore. I refused. I reported to several authorities, finally the Supreme Court of the Republic of Singapore. A fraud was implemented, I was arrested for unknown reasons, drugged, tied, and humiliated in other ways.

My present predicament is that all money is removed from my account and no lawyer in Singapore is willing to represent me. At the same time, I am hounded by Singapore Immigration, and harassed at any hotel I stay at for more than a few days. I understand I need to get out of Singapore but whoever it is chasing me is stupid enough to take all my money even as I beg it, so I cannot buy a ticket. And if the Singapore judiciary have not made fools of themselves as it is, any corrective action must acknowledge the fraud - mostly by Assistant Registrars Kenneth Wang Ye and Eunice Chan.

I do not know what to do, please help me.

Dear OHCHR,

How I have been and am being violated in Singapore is summarized in the document attached, *Helmy_OHCHR.pdf*. A friend informed me I may hear back from the DO and I did not.

Briefly: I reported illegal activity at Nanyang Technological University while employed there (please see www.nanyangscandal.com). I was fired. I took the matter to several authorities ending with the Supreme Court of the Republic of Singapore. A misrepresentation was implemented by the company filing documents into court *CrimsonLogic*, *Rajah & Tann Singapore*, and individuals at Court. When I found out that none of my documents were actually in Court, my flat was rendered uninhabitable, my phone and laptop hacked, all the money drained from my bank account, I was arrested for a reason or reasons which will not be disclosed to me unambiguously, institutionalized, drugged and made to suffer withdrawal in cycles, and humiliated in other ways.

Please see purported court documents attached, *3rd_affid_MH.pdf* and *Helmy_WS.pdf*.

Several lawyers in Singapore took my money and ran. I am unable to take any civil action because the Supreme Court has explicitly stated to me (in writing and in person and on many occasions) that they will only consider documents filed through *CrimsonLogic*, but *CrimsonLogic* takes my money and does not file my documents. A magistrate will not order an investigation and ordered me out of her chambers because the 'police report is about research and my employment is in research'. I requested help and repeatedly from several institutes including the Singapore Law Academy and Law Society of Singapore. I have no money because the bank took it all, and what little cash I had was mostly stolen from my room in a hotel. I will not call the police because they will certainly arrest me again and not tell me why. I am being hounded by Singapore Immigration and Checkpoints Authority, and must spend *c.a.* 5 hours in that establishment every few days, and am invariably insulted and told to get out, and yet am unable to because I have no money to do so. For example, I was told: 'throw yourself into international waters before three days'.

I am wondering if there is anything OHCHR may do to help me? If nothing, please be so kind so as to tell me so, so I may search for other options.
