Also, the police repeatedly rejected my invitation to visit me at my place of residence. The police however *did* take the trouble to *call my condo manager* who then called me to offer help with a security guard - of course I would not place an untrained guard at risk and to the best of my knowledge security guards have no executive power to file a police report.

Co-incidentally, I understand there has been round the clock heavy police presence in the vicinity of where I live, some kind of manhunt I assume, for the past two weeks at least. Of course, I would do anything in my power to assist apprehending any such dangerous individual so thoroughly disturbing the historical and proverbial peace of Singapore.
