[1] CPR Part 8 applies. I seek the Court's decision on a question which is unlikely to involve a dispute of fact.  
[2] In the Register of Collaborative Provision June 2022 of Imperial College of Science, Technology and Medicine (henceforth, 'ICL'), the Joint Award of bachelor in medicine and surgery is awarded by ICL and Nanyang Technological University (henceforth, 'NTU'), and both ICL and NTU are 'Jointly responsible for quality and standards'. In the Register of Professional Statutory and Regulatory Body Accreditations of ICL with degrees ending 2024-25, there is no Accrediting body for bachelor in medicine and surgery.  
[3] The QAA 'Characteristics Statement: Qualifications involving more than one degree-awarding body' do not apply. The UK Standing Committee for Quality Assessment 'The revised UK Quality Code for Higher Education' UKSCQA/02 March 2018 does apply.  
[4] I was ordered to engage in illegal activity while Research Fellow at NTU and which includes teaching and research responsibilities. I reported this to many at ICL and not Ethics at ICL only. Hancock, Jon B e-mail jonathan.hancock@imperial.ac.uk lied to me in writing about his Ethics responsibilities to me, staff and students at NTU and ICL, and the academic community. Many others at ICL did not in writing meet their responsibilities to staff and students at NTU and ICL. This is attached hancock.pdf. [5] ICL also used her power to abuse me.
