I was working at Nanyang Technological University, Singapore. About a year ago I was ordered to kill many animals without anesthesia and for no scientific reason. I was obliged to make a report and then fired.

Of course, individuals in Court, namely Registrars Kenneth Wang Ye and Eunice Chan, engaged in this fraud, along with two lawyers from Rajah & Tann, Wilson Zhu and Timothy Ang, of the Wirecard scandal.

Around the time I found out about this, my flat was broken into, my laptop and phone destroyed, and all the money in my bank account taken. I called the police: they arrested me and would not tell me why. I was tied up (literally) for a day, and then put into the Institute for Mental Health. Because they would not tell me why I was being detained, I walked out - or tried, eventually four guards held me down. I was angry of course, and

focused. Walking out involved breaking a rather large double door, though in the moment I did not think of breaking anything, merely I am walking out. I saw it being fixed the next day and thought to myself: O Sensei was right.
